# **SEA Screening Report**

South Lanarkshire Council has undertaken screening for the proposed Non-Statutory Planning Guidance - Minerals with regard to the requirements of section 9 of the Environmental Assessment (Scotland) Act 2005. The Screening Report has been submitted to the Scottish Government's SEA Gateway, setting out the views of South Lanarkshire Council on the likelihood of significant environmental effects for the proposed guidance and the potential for requiring an SEA.

# 1. Key facts

#### Responsible authority

South Lanarkshire Council

#### Title of Plan

Non-Statutory Planning Guidance - Minerals

## **Purpose of Plan**

It will provide detailed guidance on how the Council will assess minerals applications within South Lanarkshire. This Planning Guidance will be non-statutory.

### What prompted the Plan

In June 2017 it will be five years since the adoption of the current South Lanarkshire Minerals Local Development Plan (SLMLDP). The Council, however, has decided not to replace the current SLMLDP but rather to include policy guidance on minerals within the new South Lanarkshire Local Development Plan (SLLDP2). This policy will also be supported by statutory Supplementary Guidance. Work has recently started on the preparation of SLLDP2 and it is currently anticipated that the Main Issues Report should be published early in 2017. Thereafter, a Proposed Plan will be prepared and approved by October 2017 with the Plan and its associated Supplementary Guidance adopted in 2020.

In lieu of opting not to replace the SLMLDP when it expires and pending the approval of the Proposed Plan, the Council proposes to produce non-statutory planning guidance on minerals developments which would also be a material consideration in the determination of relevant planning applications within the interim period of June to October 2017.

## Plan subject

Planning - Minerals

#### Period covered by the Plan

The Guidance will be interim until the forthcoming proposed SLLDP2 is published (in October 2017); and subsequently the plan, plus its associated Supplementary Guidance, is adopted.

#### Frequency of updates

It is proposed that the Guidance will be used to provide interim advice on how the Council will assess applications for minerals applications pending the publication of the proposed SLLDP2.

#### Area covered by the Plan

The Strategy will cover the whole geographical area of South Lanarkshire (1,772 km²).

#### Summary of nature/content of the Plan

The Non-Statutory Planning Guidance – Minerals will provide guidance on how mineral planning applications would be considered and assessed by the Council. It will be a material factor in the determination of these applications.

It is anticipated that it would effectively reiterate the current minerals policies within the current Minerals Local Development Plan and not introduce new policies or coverage. It would also take cognisance of any relevant policies and Supplementary Guidance within the current adopted SLLDP.

The Council does not consider that new significant environmental effects will be identified through the preparation and implementation of the Guidance. As it is an interim measure no new effects are anticipated. The Guidance would have due regard to the Consultation Authorities comments received during consultation on the Environmental Report for the SLMLDP and for the Reporter's recommendations prior to post adoption. Due regard will also be taken of the identified mitigation and enhancement measures as set out in the SEA Post Adoption Statement of the SLMLDP and any relevant measures within the SEA of the SLLDP, and of the findings from the SEAs of the plans and strategies listed above.

It is considered that no additional effects from the Guidance will be evident and therefore effects will not be significant, cumulative or trans-boundary in nature, with no additional risk identified to either human health, natural or historic and/or the wider environment.

In light of this the Council seeks the views of the Consultation Authorities on the requirement for SEA on the Non-Statutory Planning Guidance - Minerals. If SEA is considered necessary, the Council would appreciate views as to the extent of future assessment.

18 July 2016	No	It is my understanding that the Non Statutory Planning Guidance on Minerals (the PG) will be interim guidance, created to replace the current South Lanarkshire Minerals Local Development Plan (SLMLDP). It will be in place until it is replaced by policy and supplementary guidance on minerals, which will form part of the South Lanarkshire Local Development Plan 2 (SLLDP2). The PG will reiterate current minerals policies (which have been subject to SEA) and will not introduce new policy. You consider that there will not be significant environmental effects as a result of the PG. I agree that it is unlikely that the PG itself will have significant environmental effects on the historic environment.
