SEA Screening Report

South Lanarkshire Council has undertaken screening for the proposed Sustainable Development and Climate Change Strategy with regard to the requirements of section 9 of the Environmental Assessment (Scotland) Act 2005. The Screening Report has been submitted to the Scottish Government's SEA Gateway, setting out the views of South Lanarkshire Council on the likelihood of significant environmental effects for the proposed guidance and the potential for requiring an SEA.

1. Key facts

Title of Plan

Sustainable Development and Climate Change Strategy

Purpose of Plan

The Strategy will set out the Council's approach to sustainable development and climate change. The proposed vision of the Strategy is: 'People live and work sustainably in South Lanarkshire while respecting and enjoying the benefits of a high quality environment'.

The Strategy will enable the Council to continue to meet its statutory requirements relating to sustainable development and climate change as set out by the Local Government (Scotland) Act 2003 and the Climate Change (Scotland) Act 2009.

What prompted the Plan

The current South Lanarkshire Sustainable Development Strategy will come to an end in March 2017. This is to be replaced with a new five year strategy - Sustainable Development and Climate Change Strategy which will make the connections between sustainable development and climate change more explicit.

Plan subject

Sustainable Development and Climate Change

Period covered by the Plan

April 2017 to March 2022.

Frequency of updates

An action plan will accompany the Strategy. The action plan will be reviewed and updated annually. The Strategy itself will be subject to a mid-term review in 2019/2020.

Area covered by the Plan

The Strategy will cover the whole geographical area of South Lanarkshire (1,772 km²).

Summary of nature/content of the Plan

It is anticipated that the new Strategy will closely follow the structure and content of the current Sustainable Development Strategy.

It is currently proposed that the new Strategy will have three themes with eight strategic outcomes. These are:

Theme 1 - Sustainable Council: Considers the Council's own impact on the environment and what we and our partners will do to minimise it.

Outcomes:

- The Council's carbon emissions are managed and reduced.
- The Council is environmentally responsible in the procurement, use and disposal of resources.
- Climate change duties are further embedded in the delivery of Council services and its collaborations with partners on climate change mitigation and adaptation.

Theme 2 – Sustainable Environment: Considers what the Council is doing to protect, enhance and respect the quality of the natural environment contributing to the health and wellbeing of local communities.

Outcomes:

- South Lanarkshire's natural environment is protected, enhanced and respected.
- South Lanarkshire's enhanced environments provide health and wellbeing benefits to local communities.

Theme 3 – Sustainable Communities: Considers how the Council's services will help provide places for people to live and work in an environmentally responsible way and be better prepared for a low carbon Scotland.

Outcomes:

- Homes and buildings are energy efficient, environmentally sustainable and fuel poverty is minimised.
- The Council contributes to the reduction of Scotland's carbon emissions and how it adapts to climate change impacts, through implementation of its strategies, plans and policies.
- Local communities are supported in taking action to be more environmentally responsible.

3. Summary of environmental effects

The current Sustainable Development Strategy has promoted and fostered a positive culture of environmental awareness and actions throughout the Council and with our partners. The new Strategy is intended to build on this progress and to further develop the Council's approach to sustainable development and to address the challenges and opportunities of climate change.

It is proposed that the new Strategy will closely follow the structure and content of the current Strategy, as this approach has proved to be successful in delivering positive outcomes in terms of sustainable development and climate change.

The current Sustainable Development Strategy was subject to a full SEA (SEA\\00580). It closely aligns to the Council Plan 'Connect' (SEA\\00572) and to the Community Plan (SEA\\00489), and sits directly beneath these Plans which have both undergone SEA in their own right

The Council does not consider that new significant environmental effects will be identified through the preparation and implementation of the proposed Sustainable Development and Climate Change Strategy. Any new effects are anticipated to be as a result of further augmentation of existing approaches and will be minor and positive in nature. Should potential additional effects be identified, appropriate enhancement or mitigation measures will be considered within the Strategy. The new Strategy will have due regard to the Consultation Authorities comments received during consultation on the Environmental Report for the current Sustainable Development Strategy. Due regard will also be taken of the identified mitigation and enhancement measures as set out in the SEA Post Adoption Statement of the Sustainable Development Strategy and of the findings from the SEAs of the Community and Council Plans.

It is considered that no additional effects from the Sustainable Development and Climate Change Strategy will be evident and, therefore, effects will not be significant, cumulative or trans-boundary in nature, with no additional risk identified to human health, the natural or historic and/or the wider environment.

In light of this the Council seeks the views of the Consultation Authorities on the requirement for SEA on the Sustainable Development and Climate Change Strategy. If SEA is considered necessary, the Council would appreciate views as to the extent of future assessment.

However, we also note that the Council considers that it is unlikely that <i>new</i> significant environmental effects will be identified beyond those which have previously been identified and assessed through the SEA of other related plans and strategies, including the current Sustainable Development Strategy. In view of the above and the information contained in the screening report, and in terms of our interests, we agree that the Strategy is not likely to have significant environmental effects. |
