THE SOUTH LANARKSHIRE COUNCIL (REPLACEMENT OF CLYDE BRIDGE BY PETTINAIN) COMPULSORY PURCHASE ORDER 2020

SOUTH LANARKSHIRE COUNCIL, a local authority established in terms of the Local Government etc (Scotland) Act 1994 and having their Main Office at Council Offices, Almada Street, Hamilton ML3 OAA (hereinafter referred to as "the Acquiring Authority") in exercise of the powers conferred on them by Section 104 of the Roads (Scotland) Act 1984 hereby make the following Compulsory Purchase Order:-

- 1. This Order may be cited as The South Lanarkshire Council (Replacement of Clyde Bridge by Pettinain) Compulsory Purchase Order 2020.
- 2. Subject to the provisions of this Order, the Acquiring Authority are hereby authorised to purchase compulsorily for the purpose of carrying out works in terms of a road improvement scheme to replace the existing Clyde Bridge road bridge and improve and re-align the C29 road on approach to the Bridge, the land which is described in the First Schedule hereto and is delineated red and coloured pink on the map signed with reference to this Order and marked "Map referred to in The South Lanarkshire Council (Replacement of Clyde Bridge by Pettinain) Compulsory Purchase Order 2020", which Map is incorporated in this Order.
- 3. In relation to the foregoing purchase, in respect of Plots 1, 2, 3 and 4, Section 70 of the Railway Clauses Consolidation (Scotland) Act 1845 and Sections 71 to 78 of that Act as originally enacted and not as amended for certain purposes by Section 15 of the Mines (Working Facilities and Support) Act 1923 is hereby incorporated with the enactment under which the said purchase is authorised subject to the modifications that references in the said sections to the Company shall be construed as references to the Acquiring Authority and references to the Railway or Works shall be construed as references to the land authorised to be purchased and any buildings or works constructed or to be constructed thereon.
- 4. The registration of a conveyance, as defined in section 106(5) of the Title Conditions (Scotland) Act 2003, in implement of this Order shall not extinguish the real burdens or

servitudes in the deeds referred to in the Second Schedule hereto.
