Your rights

You have the right to ask us to:

- tell you that we are using your personal information about you, tell you what that
 information is and who we have shared it with. You can also ask for a copy of the
 information we have about you. This is called the right of access
- correct any wrong or misleading information personal information that we have about you. This is called the right to rectification
- stop using any of all of your personal information. This is called the right to object
- delete or destroy your personal information under certain circumstances. This is called the right to erasure
- stop using your personal information until we can correct your personal information, give you our reasons for using your personal information or stop us deleting your personal data if you need it in connection with any legal claims. This is called the right of restriction
- pass you personal information to someone else under certain circumstances. This is called the right to data portability
