



**South Lanarkshire Council
(Use of Off-street Parking Places) Consolidation Order 2011,
Amendment No.2 Order 2023**

On the 16 April 2024, South Lanarkshire Council made the above named Order, under the terms of the Road Traffic Act 1984, thereby introducing regulated disabled persons' bays, electric vehicle bay and Scotrail vehicle bays, all within Bannatyne Street car park, Lanark.

The Order which comes into operation on the 3 June 2024, was advertised in the East Kilbride News in the week beginning the 16 October 2023. The effect of the order is as previously stated.

A copy of the Order and a map relative thereto are available for inspection on the council's website.

Any person who wishes to question the validity of the order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it, has not been complied with in relation to the Order may, by the 28 May 2024, apply to the Court of Session for this purpose.

Preliminary Report

For the introduction of a regulation within a car park

Location: Bannatyne Street car park, Lanark

Proposal: Introduction of a regulation within a car park

1. Bannatyne Street car park, Lanark is situated to the east of Lanark town centre and is located off Bannatyne Street, and to the south of Lanark Railway Station.
2. There are currently no restrictions within Bannatyne Street car park.
3. The existing Bannatyne Street car park (Lanark train station car park) has been changed into a car park with disabled persons' spaces, as part of the wider Lanark Interchange scheme. Disabled persons' badge holders will be unable to make use of the disabled persons' spaces if there is inconsiderate use of the spaces by non-blue badge holders.

Within the car park there are also Electric Vehicle charging bays and bays for the exclusive use of Scotrail vehicles.

4. It is proposed to limit the use of the disabled persons' parking bays to vehicles displaying a valid disabled person's badge within Bannatyne Street car park. There will also be bays marked for Electric Vehicles and bays for the exclusive use of Scotrail vehicles.

5. The Chief Constable, Strathclyde Partnership for Transport and the Local Members have been consulted and have no objections to the proposals.
6. It is recommended, therefore that South Lanarkshire Council advertises its intention to make a Traffic Regulation Order introducing regulated disabled persons' bays, electric vehicle bay and Scotrail vehicle bays, all within Bannatyne Street car park, Lanark.

South Lanarkshire Council in exercise of the powers conferred on them by Sections 35(1) and (3), 3(A), 35A and 35B and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act hereby make the following order.

1. This order may be cited as "South Lanarkshire Council (Use of Off-street Parking Places) Consolidation Order 2011, Amendment No.2 Order 2023" and shall come into operation on the 3rd day of June 2024.
2. The order specified in the schedule to this order shall have the effect subject to the amendments specified in that schedule.
3. Signed for and on behalf of South Lanarkshire Council by Colin Park, Head of Roads, Transportation and Fleet Services, on the Sixteenth day of April, Two Thousand and Twenty Four.

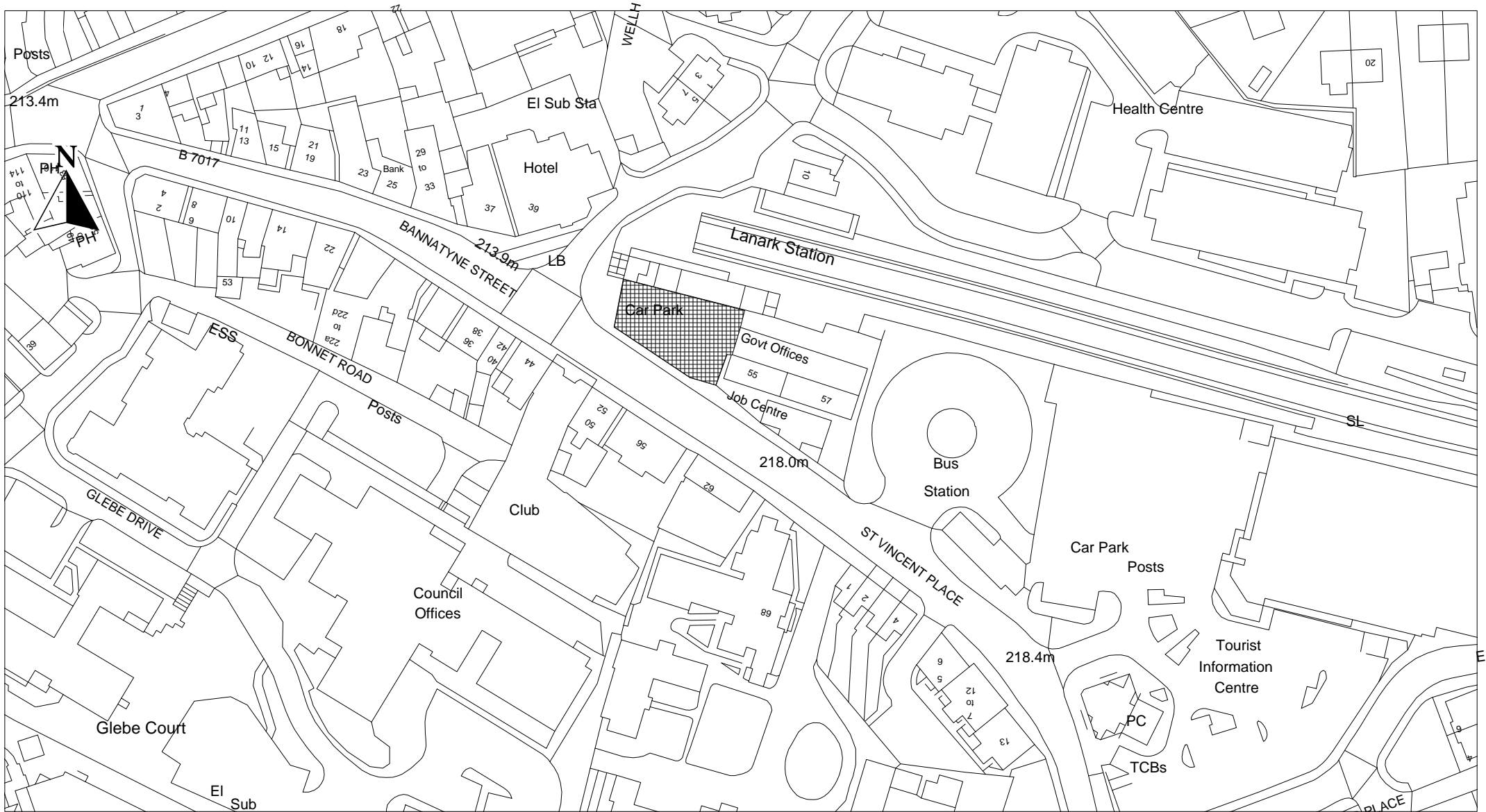
