

#### South Lanarkshire Council (Zig Zags at Schools) Order 2010, (Amendment No.1) Order 2023

On the 22 April 2024, South Lanarkshire Council made the above named Order, under the terms of the Road Traffic Act 1984, thereby extending the zig zag markings, which prohibit the stopping of vehicles, on Johnstone Road, Hamilton, fronting Woodside Primary School.

The Order which comes into operation on the 12 August 2024, was advertised in the Hamilton Advertiser in the week beginning the 9 October 2023. The effect of the order is as previously stated.

A copy of the Order and a map relative thereto are available for inspection on the council's website.

Any person who wishes to question the validity of the order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it, has not been complied with in relation to the Order may, by the 3 June 2024, apply to the Court of Session for this purpose.

# **Preliminary Report**

# For the introduction of Restrictions on zig zag markings in the vicinity of schools

- 1. Johnstone Road, Hamilton is located between Gateside Street/Portland Place and Silvertonhill Avenue and gives access to residential properties and Woodside Primary School.
- 2. The current restrictions on Johnstone Road are no stopping, Monday to Friday, 8.30am to 4pm (zig zags) and no waiting all week 8am to 9pm.
- 3. Vehicles parking on Johnstone Road, within the vicinity of Woodside Primary School, reduce visibility for pedestrians and compromises road safety.
- 4. It is therefore proposed to extend the zig zag markings on Johnstone Road, fronting Woodside Primary School, to prohibit vehicles from stopping between 8.30am and 4pm, Monday to Friday.
- 5. The Chief Constable, Strathclyde Partnership for Transport and the Local Members have been consulted and have no objections to the proposals.
- 6. It is recommended, that South Lanarkshire Council advertises its intention to make a Traffic Regulation Order extending the zig zag markings, which prohibit the stopping of vehicles, on Johnstone Road, Hamilton, fronting Woodside Primary School.

### South Lanarkshire Council (Zig Zags at Schools) Order 2010, (Amendment No.1) Order 2023

South Lanarkshire Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

- This Order may be cited as "South Lanarkshire Council (Zig Zags at Schools) Order 2010, (Amendment No.1) Order 2023" and shall come into operation on the 12<sup>th</sup> day of August 2024.
- 2. In this Order the following expressions have the meanings hereby assigned to them:-

"vehicle" unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power;

3. Amendments

The Order specified in Schedule 1 to this Order shall have effect subject to the amendment specified in that Schedule.


"From a point 12 metres north-west of the extended north-west kerbline of Silvertonhill Avenue, north-westwards for a distance of 135 metres or thereby."
