GUIDE TO INFORMATION AVAILABLE THROUGH THE OUR PUBLICATION SCHEMES 2017

The Freedom of Information (Scotland) Act 2002 (the Act) requires Scottish public authorities to produce and maintain a publication scheme. Authorities are under a legal obligation to:

- publish the classes of information that they make routinely available
- tell the public how to access the information and what it might cost.

Lanarkshire Valuation Joint Board and the Assessor for Lanarkshire Valuation Joint Board have adopted the **Model Publication Scheme** produced by the Scottish Information Commissioner on 29 March 2016.

Availability and formats

The information we publish through the model scheme is, wherever possible, available on our website. We offer alternative arrangements for people who do not want to, or cannot, access the information online or by inspection at our premises. For example, we can usually arrange to send information to you in paper copy (although there may be a charge for this - see charges below).

Exempt information

We will publish the information we hold that falls within the classes of information below. If a document contains information that is exempt under Scotland's freedom of information laws (for example sensitive personal information or a trade secret), we will remove or 'black out' the information before publication and explain why.

Lanarkshire Valuation Joint Board and the Assessor for Lanarkshire Valuation Joint Board hold the copyright for the vast majority of information in the publication schemes. All of the information can be copied or reproduced without our formal permission, provided it is copied or reproduced accurately, is not used in a misleading context, and provided that the source of the material is identified.

The publication scheme may, however, contain information where the copyright holder is not Lanarkshire Valuation Joint Board or the Assessor for Lanarkshire Valuation Joint Board. In most cases the copyright holder will be obvious from the documents. In cases where the copyright is unclear, however, it is the responsibility of the person accessing the information to locate and seek the permission of the copyright holder before reproducing the material or in any other way breaching the rights of the copyright holder.

Charges

The Edited Electoral Register

This version of the electoral register does not include the names of those electors whose names appear in the Full version of the Register but who have taken advantage of the Representation of the People Legislation and chosen to have their names excluded from the Edited version of the Register, which can be sold to anyone. The charges are detailed below:

a) Data Format Copy

The fee for purchasing a copy of the register in data format, is at the rate of £20 per Constituency plus £1.50 for each 1,000 entries (or remaining entries) in it.

b) Printed Paper Copy

The fee for purchasing a copy of the register in the printed form, is at the rate of £10 per Constituency plus £5.00 for each 1,000 entries (or remaining entries) in it

There are a small number of pre-printed publications for which the Assessor for LVJB makes a charge. These documents include the Valuation Roll (including Draft Valuation Roll) and Council Tax Lists

Valuation Roll (including Draft Valuation Roll) Charges

- Paper Copy: Full Set £120, UA Area £60
- Certified Extracts: £10 per entry
- Photocopy: 10 pence for each page

Council Tax List Charges

- Paper Copy: Full Set £150, UA Area £75
- Certified Extracts: £10 per entry
- 1989 RV Certification £10 per entry
- Photocopy: 10 pence for each page

We may charge for providing information to you e.g. photocopying and postage, but we will charge you no more than it actually costs us to do so. We will always tell you what the cost is before providing the information to you.
